("EAGLE"), manufacturer of **EAGLE DIAMOND CONTROL BOARD** warrants, to the original owner, all parts and components of the "Control Board", which is registered to the original owner and normally operated, to be free from defects in material and workmanship for a limited period of time beginning on the date of purchase by the original owner (the "warranty commencement period") and expiring **one (1) year** following the warranty commencement date if originally installed for use and service in connection with a single family **residential** application or **commercial** application.

Note: This warranty covers repairs needed to correct defects in materials or workmanship of all parts and components of each new Diamond Control Board manufactured and supplied by EAGLE; excepting that, this limited warranty does not cover the following: corrosion and damage or failures resulting from environmental conditions, vandalism, water, lack of or improper maintenance, accident, theft, fire, normal wear and tear, misuse, alteration, tampering, improper installation, improper repair, installation of non-EAGLE approved parts, accessories, or components. To obtain warranty service, you must return the damaged parts or operator, at your expense, to:
