SYSTEM INFORMATION

INSTALLATION	The Sikaplan Disc is positioned in the seam on the surface of the Sikaplan Fastened membrane at the designated on-center spacing with a Sikaplan fastener placed through the center and fastened to the approved roof deck, clamping the membrane in place.
AVAILABILITY	The Sikaplan Disc is available directly from Sika Authorized Applicators when used within a Sikaplan roofing system.
MAINTENANCE	Standard maintenance of roofs should include regular inspection of flashings, drains and termination sealants at least twice a year and after each storm.
